

## ELKESLEY PARISH COUNCIL

### Unapproved Minutes of the Meeting of the Elkesley Parish Council

The Meeting of the Elkesley Parish Council was held in the Elkesley Memorial Hall, High Street, Elkesley on 15<sup>th</sup> December 2015 at 7.00pm.

**1203/15 Present:** Cllr Oldbury, Cllr Raper, Cllr Fish, Cllr Flear, Cllr McCaffrey, Cllr Simpson, Cllr Stronach Cllr Hurst

**Others present:** 5 members of the public

Cllr Oldbury took the minutes and Cllr Raper chaired the meeting.

**1204/15 To receive apologies for absence**

Apologies received from Cllr Woodcock.

**1205/15 To receive and record declaration of interests from Members in any item to be discussed**

No declaration of interests received.

**1206/15 To approve the minutes of the meeting held 17<sup>th</sup> November 2015**

The minutes of the meeting were approved and the Chair duly signed the minutes.

**1207/15 To hold a 10 minute public session**

Mrs Douglas shared a map of Elkesley and talked through the focus of the EPVG. The group has been wound up for the time being. Their main focus has been path 'D', the land where this is owned by Carrs and leased to the Forestry Commission. There is no right of access and no support has been offered by the Forestry Commission for opening it up.

Mrs Douglas mentioned other paths from the map and access issues relating to them. The landowner where there is access to stony bridge is happy for it to be improved and some villagers will be working on this during the year. Notts CC will potentially upgrade Crookford bridge – budget permitting. The hedges and potholes on Brough Lane have been addressed. The path alongside Plevins has been improved. The EA have agreed to boulders to be placed in the river in response to the 4x4 driving downstream. The Forestry has to apply to the EA for this to be done.

**Action:**

Cllr Dukes to be asked to contact the Forestry commission about this application

Mr J Stronach will be leading on the seating project around the village

Money left from the EPVG to be held by the PC for 1 year in case the group re-forms. If they don't then the money is to be ring-fenced and spent on 'paths'

**1208/15 To receive a report from the District Councillor**

District Councillor Dukes was unable to attend.

County Councillor John Ogle was unable to attend.

**1209/15 Planning – To consider any planning applications, note any correspondence and decision notices**

Application: Notts County Council Ref: F/3409  
 Location: A1 metal recycling  
 Proposal: Construction of new office and weighbridge (retrospective)

The Council discussed the above application and it was agreed to find more details over the application before making comment.

**1210/15 To receive an update on the Robin Hood Pub**

The Community Asset listing is being appealed for the second time and it will now go to tribunal. As the PC made the original listing they have been asked if they would like to make representation. Due to the timescale, they said they would (this had to be confirmed before the PC meeting).

**1211/15 Proposal to discuss right of way on Battery Lane**

Cllr Hirst explained and outlined the position regarding ownership. A proposal was made to approach the Definitive Map Officer to clarify officially the status of the lane and to request County Councillor J Ogle to help get a speedy resolution

Proposed by Cllr Hirst and seconded by Cllr Stronach it was resolved by 6 votes and 2 abstained (JF, BS)

**1212/15 Progress report on the defibrillator**

This is now installed, functioning and registered

**1213/15 To approve payments and receive financial update**

The Clerk previously circulated copies of the current finances and bank statements for the Councillors to view.

**1214/15 To discuss the village grass cutting costs**

**1215/15 To discuss budget ideas for 2016**

£1000 to be set aside for maintenance and upgrade work to the play area  
An amount to be allocated for seating materials

**1216/15 To receive village reports****a) Sports Field and play equipment**

No report made.

Action: Cllr Oldbury to find details/costs for fixing the gates and powder coating them.

**b) Update on the BMX track**

Carillion have funded the building of the track, the grant that had been given for this purpose is still in the PC account and has to be used for associated BMX activities. Cllr Oldbury has spoken with Mr Brown (BDC) who has said this is ok. Cllr McCaffrey expressed concern over the surface of the track as it was 'soft'. It is thought that the weather has been so poor it hasn't been able to dry and harden.

**c) Highways**

Concern expressed over a lack of light at the junction on Coal Pit Lane with the bridge road. The position of the new road signs within the village are causing confusion

Action: Contact NCC to determine options available regarding a light at the junction and relocation/replacement signs

**d) Cemetery**

There is no resolution regarding the lack of a water supply for the cemetery.

**e) EPVG**

Report made during public session.

**f) A1 Bridge**

Nothing to report.

Cllr Woodcock to report on the grass cutting options.
